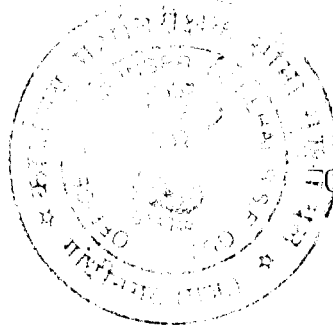
GENERAL INSTRUCTIONS FOR THE CANDIDATES

1. Candidates should, in addition to their Admit Card, bring:
 - a) Two copies of their latest colored photo (3 cm x 3.5 cm).
 - b) At least one photo identity proof in ORIGINAL with clear photograph (e.g. AADHAR Card, Driving License, University/College ID, Voter ID Card, PAN Card, etc)

Note: If a candidate fails to bring the above documents, he/she would not be admitted in the examination venue and his/her candidature could be cancelled.
2. Candidates shall be permitted to appear in the exam only at the venue as specified in the Admit Card.
