2. Quotation documents can be received from office of the IG STC BSF Chakur up to 1800 Hrs. on any working day. Issue of quotation will be closed on 18/06/2019 at 1400 Hrs and receipt of application for issue of quotation will be closed on same day at 1100 hrs.
3. Quotation will be opened at 1630 Hrs. on the same Day i.e. 18/06/2019 and the quotation received thereafter will not be accepted after 16:00 Hrs. on the same Day i.e. 18/06/2019.
4. Quotation can be deposited in tender box placed in the Office of the IG STC BSF Chakur and name of work be super-scribed on the envelope with Registration/Authorized certificate/GST NO./PAN Card and works order of three similar nature of works required for firms who not have authorized certificate etc.
5. The Quotation will be opened at STC BSF Chakur by a Board of Officers on the date and time mentioned above.
6. The firms should quote their rates in figure as well as in words. The offer of the firm will remain valid up to 03 Months from the date of opening.
7. Any Overwriting/ erasing/cutting of the rates quoted by the firms will be liable for rejection of quotation submitted until and unless same are properly initialed and re-written by the Firms.
8. Any canvassing in this regard is strictly prohibited. The quotations of the quotations who resort to canvassing will be liable for rejection.
9. Acceptance of quotation will rest with the Executive Engineer(Elect),FTR HQ BSF Gandhinagar , who does not bound himself to accept the lowest quotation and reserve the right to accept or reject any or all the quotations without assigning any reason there of and his decision shall be final and binding upon all.
10. After acceptance of Quotation by the Competent Authority 5 % of the quoted amount as performance guarantee should be deposited in shape of BD/BC/CDR/FDR in favour of IG STC BSF chakur and same shall be valid for six month and will be released after completion of guarantee/maintenance period i.e six months shall be reckoned from the date of issue completion certificate.

11. Parts /spares only will be used in repair maintenance as per scheduled estimate same should be made by Crompton Gravies (p) India .Ltd. and no local/other company make-spars will be accepted without previous approval of engineer in charge.
12. The Work will be completed within 02 months from the date of issue of Work order.
13. Rates quoted shall be inclusive of all taxes and nothing extra on account of transportation, local taxes, GST etc will be paid by the department.
14. Work order to the successful quotation will be issued on CPWD form 11 & work will be executed per CPWD specifications and directions of the Engineer in charge .
15. Income tax and GST etc. will be deducted from the bill of firms as per central Govt. Rules.
16. Due to administrative reason if work order not placed after acceptance of rates Deptt. Will not be responsible for any compensation.
