Enlistment of the contractors should be valid on the last date of submission of tenders. In case the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders.

Tenders will be issued to eligible non CPWD contractors provided they produce definite proof from the appropriate authority which shall be to the satisfaction of the competent authority, of having satisfactory completed similar work of magnitude specified below :-

Three similar works each value not less than 40 % of estimated cost or two similar work each of value not less than 50 % of estimated cost of one similar work of value not less than 80 % of estimated cost in last 7 years ending last day of the month previous to the one in which the tenders are invited is required. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7 % per annum, calculated from the date of completion to the last date of bidding for tender.

Similar work shall mean work **related to Building & Road works**

Tender documents shall be considered valid of only contractors who will upload within the prescribed date & time:
