- An undertaking that "The physical EMD shall be deposited by me/us with the Office of **Sector HQ BSF Barmer**, in case I/We become the lowest tenderer within a week of the opening of the financial bid otherwise department may reject the tender and also take action to withdraw my/our enlistment.


**NOTE:** - Certified copies of all the above documents and tender fees in prescribed form shall have to be submitted physically in the Office of **DIG SHQ BSF BARMER** within the prescribed time. If all the documents uploaded are found in order only then financial bid of bidder shall be opened.

Online Bid documents submitted by intending bidders shall be opened only of those tenderer, who have uploaded the scanned copies of the required documents and if these documents are not found in order.

Earnest money to be deposited in the form of Receipt treasury Challan/ Deposit at Call receipt of a scheduled bank/fixed deposit receipt of a scheduled bank/ demand draft of a scheduled bank issued in favour of **DIG SHQ BSF Barmer**.
