NOTICE INVITING e-TENDER

The Assistant Engineer/AC(Works) , Ftr HQ BSF Gujarat invites on behalf of the President of India, online Percentage Rate tenders from approved and eligible contractors of CPWD and those of appropriate list of MES, BSNL, Railways, State PWD for the following works through e-procurement solution:-

Enlistment of the contractors should be valid on the last date of submission of tenders. In case the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders.

Tenders will be issued to eligible non CPWD contractors provided they produce definite proof from the appropriate authority which shall be to the satisfaction of the competent authority, of having satisfactory completed similar work of magnitude specified.

Tender documents shall be considered valid of only contractors who will upload within the prescribed date & time:

(A) Scanned copies of the following documents to be uploaded :

- i) Scanned copy of Earnest Money and cost of tender documents in prescribed form in favour of **IG BSF Gujarat**.
- ii) Scanned copy of valid Registration Certificate of CPWD and appropriate category of MES, Railways, BSNL & State PWD.
- iii) Scanned copy of Registration Certificate under GST.
- iv) Contractor should quote their rate including GST charges as per government norms.

The following undertaking in this regard shall also be uploaded by the intending bidders:-

- v) "The physical EMD shall be deposited by me/us with the Office of **Ftr HQr BSF Gujarat**, in case I/We become the lowest tenderer within a week of the opening of the financial bid otherwise department may reject the tender and also take action to withdraw my/our enlistment"

NOTE: Certified copies of all the above documents and tender fees in prescribed form shall have to be submitted physically in the office of **FTR HQ BSF Gujarat** within the prescribed time. If all the documents uploaded are found in order, only then financial bid of bidder shall be opened.

Online bid documents submitted by intending bidders shall be opened only of those tenderer, who have uploaded the scanned copies of the required documents and if these documents are found in order.

Earnest money to be deposited in the form of Receipt Treasury Challan/Deposit at Call receipt of a scheduled bank/fixed deposit receipt of a scheduled bank/demand draft of a scheduled bank issued in favour of **IG BSF Gujarat**.
